

Referee abuse will not be tolerated.

- Any instance of referee abuse will be reported to US Club Soccer.
- Violations will be addressed using the USSF Referee Abuse Penalty Matrix.
- FCL will impose sanctions for any reported abuse that falls within the yellow and orange categories (non-physical and physical offenses), as outlined in the USSF RAP Penalty Overview.

Red Card Procedure

- A red card results in a **minimum one (1) game suspension**, including red cards issued as a result of two cautions.
- If a player is sent off during a weekend, they may not participate for the remainder of that weekend, regardless of the event.
- Games missed during the weekend count toward the suspension if noted on the roster and/or referee game report.
- Any team that uses a suspended player will be subject to sanctions, and the player will be considered ineligible.

Red Card Reporting

- Notification: The club assignor or site representative must notify the NFR Soccer League Coordinator within 48 hours of the incident.
- **Submission**: Email the completed game card and red card supplement form to:
 - NFRSoccer@gmail.com
- Referee Report Must Include:
 - Full incident description and reason for the red card.
 - o Player's full name, jersey number, and Player ID number.
 - Match cards from both teams.
- Additional Sanctions: US Club Soccer may impose further penalties for severe or repeat offenses.



Suspension Rules

- Red card suspensions apply as follows:
 - Suspension for the remainder of the match.
 - Suspension must be served in the next scheduled league match with the player's primary rostered team.
- A suspended player may not play for any other team or club until the suspension is fully served.
- Carryover Rule: Suspensions not served before the end of a season carry over to the next season, even if the player changes clubs.
- Alternate Team Requests:
 - If a suspension cannot reasonably be served with the primary team, the club's Executive Director or Director of Coaching may request approval from the PDE Committee to serve with another appropriate team in the same age group.
- Verification:
 - Suspension must be recorded on the official match report.
 - o The player must be listed on the roster and marked as serving the suspension.

Appeals

Appeals may only be submitted in the following cases:

- **Mistaken identity** by the referee.
- Red card suspensions with sanctions determined by the FCL PDE Committee.

Compliance with this policy is mandatory for all clubs, teams, coaches, and players participating in FCL competitions.
